This environmental data sheet shows the environmental information of ACRISYL PITTURA RIEMPITIVA: LCA. LEED and other information.

ACRISYL PITTURA RIEMPITIVA anti-algae is a waterbased outdoor paint with a base of acrylic-siloxanic resins in aqueous dispersion and filler aggregates, to protect outdoor wall surfaces.

It is suitable to re-paint wall finishing coating on thermal insulating system.

With features like high water repellence, high washing resistance, resistance to atmospheric agents, pollution and the alkaline environment typical of concrete surfaces and plasters in general.

The best looking results are achieved by applying on very regular, firmly compact surfaces containing inert

substances with a fine grain size.

LIFE CYCLE ASSESSMENT

Life Cycle Assessment (LCA) is a tool to quantify the environmental impact of a product or service throughout its entire life cycle. The LCA methodology, as defined by ISO 14040/44 [1-2], consists of four phases:

- goal and scope definition
- inventory analysis
- impact assessment
- interpretation

The LCA calculation method of San Marco has undergone a critical review by a third part guditor [3].

Goal and scope

The goal of this LCA is to provide transparency about the environmental performance of ACRISYL PITTURA RIEMPITIVA, to create improvement options and support environmental communication. The functional unit is 1 kg of paint including packaging, with a spreading rate of 0,349 kg/sqm (considering 2 coats). This LCA is a "from cradle to gate with options" study. The system boundaries include raw materials, their transportation, processing, packaging and the product and its packaging disposal. Distribution, application, use phase and demolition are excluded because these phases are highly variable.

Inventory analysis

Primary data are used to the most significant processes, like the paint recipe, packaging and factory consumptions and emissions. Data refer to 2014 and are collected at the San Marco Group's factories located in Marcon (VE), Latisana (UD), Forlì, Montemarciano (AN) it refers to the type "BIANCO" in the 15 I size (code 6340019/15). The end of use of the product and his packaging refers to the Italian situation. Secondary data originate from the ecoinvent v3.1 database [4]. The LCA calculations are performed with the LCA software SimaPro 8.1 [5].

Impact assessment

Life cycle impact assessment has been done with the method PCR 2012:01 v2.0. "Construction products and cpc 54 construction services" [6], as indicated in the EPD programme of the International EPD Consortium. This method consists of different environmental indicators including the Carbon Footprint, energy content, material resource consumption, water consumption and waste. Table 1 shows the LCA results.

Interpretation

The LCA results indicate that the largest contributions come from upstream processes (i.e. raw materials). The global warming potential of 1 kg of ACRISYL PITTURA RIEMPITIVA is 1.613 kg CO_2 eq and its water consumption is 22 litres. The negative value of renewable energy content is caused by the pallet reuse.

LEED

LEED means Leadership in Energy and Environmental Design. It is a voluntary program that provides third-party verification of green buildings. It provides building owners and operators a tool to understand their building's environmental performance and to create healthy indoor spaces.

In order to obtain LEED certification, projects must satisfy prerequisites and earn points (there is a threshold). The number of points the project earns determines its level of LEED certification.

LEED is a certification system that deals with the environmental performance of buildings based on overall characteristics of the project. Although LEED does not certify products and services of individual companies, products and services do play a role and can help projects with credit achievement

The table below shows ACRISYL PITTURA RIEMPITIVA potential contribution to the different LEED credits of the LEED 2009 Rating System for New Construction and Major Renovations [7] and of LEED v4 Building Design and Construction [8]. Table 2 shows the possible contribution of the paint to potential credits, if used properly.
